## ADRA - Minutes of the Annual General Meeting

held on 26st April 2016 at Amersham Free Church Hall

### **1 Chairman's Welcome**

The Chairman welcomed approximately 50 members to the 55th Meeting of the Association.

### **2 Apologies for Absence**

### **3 Minutes of AGM held on 21nd April 2015**

Adoption of the Minutes was proposed by Tony Westhead and seconded by Guru Guruswamy.

### **4 Treasurer's Report (Geoff Platts)**

### **5 Planning Officer's Report (Les Jayatilaka)**

Liz Jones updated the meeting on the proposed Waste Transfer Station, London Road East, Amersham. A year on from the Development Control Committee passing a resolution to approve the WTS, there has still been no decision notice issued. We don't know why Bucks CC is delaying things in this way. Our lawyer advised us to write to Bucks CC and state all the problems, they have replied and said there are no problems so now waiting to see. At the moment all we know is that they intend to approve it. Looking to see if we go to Judicial Review.



Bron Curley commented on Cargo/Iceland site redevelopment. It's important to remind ourselves that although there is a lot of emotion around this site we comment on planning applications based on planning rules. Is it appropriate use of space, does the new planning application satisfy the requirements in terms of change of use etc. We can't comment on who buys the space. Planning rules do not include whether you want a discount supermarket. Commercial issues should be separated from the planning issues.

**Draft Development Plan – comment from Mark Flys, Chiltern District Council.**

If we don't create a plan one will be imposed upon us. Joining with South Bucks does have some advantages. Between the two authorities they are looking for potentially 15,000 dwellings of all types. There is planning in for about 1,500 of those. There will still be a shortfall of approx. 7,500. What they then do is start negotiating with bordering authorities like Aylesbury Vale to see if they can take some of that into their area. At the moment they are looking at potential sites, will then test infrastructure and what can be done with it. This is worst case scenario if we don't hit targets. 7,500 shortfall includes affordable housing allocation.

**Question from Bron Curley to Mark Flys: Is there any provision for schools and essential amenities?**

Mark Flys: My understanding is that comes in stage 2, where they have identified those sites and they then look at infrastructure, schools etc. It is part of the process and they have to cost that into the site about what is needed to support the site. Stage 2 consultation will be in October/ November.

**Question from member: Concerned that Green Belt and AONB is proposed as part of this test local plan. Also concerned that ADRA did not think it necessary to take a position as an organisation. Best**



**responses have been from Chesham Bois Parish Council, Chiltern Society. ADRA seemed to dismiss vast chunk of land which will link Chesham and Little Chalfont on the back of Amersham which is a sizeable piece of Green Belt/ANOB.**

Reply from Les Jayatilaka: Have looked at it from our Amersham Residents Association point of view, we seem OK in terms of what we need to deliver. Would rather things stay the same but faced with having Central Government telling us what to do I would rather see control than an imposition.

Comment from Mark Flys: These are Green Belt sites that we're talking about which is part of the process, they are also looking at every brown field site in the area and also part of the plan is to look at opportunities for employment as well. Green Belt area is a last resort.

### **Member comment on Hyrons Bridge:**

Many years ago the roundabout between Batchelors Way and Highland Road was a proper roundabout and there were no problems with people coming from Highland Road and turning right to the bridge. Since the roundabout has been removed and a mini roundabout put there people turn right the wrong way. Have witnessed accidents there and written to Council but nothing has been done.

Linda Flett: Met with Martin Tett who said to let him know the number of accidents or near misses, but he has not received any information.

Member suggested a raised kerb might help.





Member said that at the Orchard Lane end the white lines should be painted more regularly because it is not clear who has right of way.

Mimi Harker: A number of people with mobility scooters use the bridge and they have complained about road surface.

### **Discussion about planting trees in Sycamore Road and Hill Avenue:**

Steve Catanach from Amersham Town Council said they were very small conical trees which won't affect anything underground other than services. They go straight up, don't affect the traffic. Bring a bit of shade and colour to the area to lessen the harshness of the concrete. Concerns from members about leaves dropping on road and not being cleared away regularly.

Mimi Harker: Amersham Action Group consulted the community on numerous occasions and people voted in favour of trees. Suggested asking the question again at the Amersham Carnival.

Member questions: Will there still be space for the market and pedestrians? Steve Catanach replied that there would be more space because they would take up less space than the concrete planters currently in use.

Member concerned about tree roots damaging and lifting the pavements. Steve Catanach replied that these trees have a small root ball that won't damage the pavement.

Number of trees proposed: 14 in Sycamore Road and 7 in Hill Avenue. Funding needed for survey to check the services in the pavements.



Mark Flys and Steve Catanach to talk about it at next council meeting.

Chairman, Treasurer and Booking Secretary stepping down. Looking for people to take over. Amersham Town Council have been approached and are looking at taking over the running of it, there are some legal issues which need to be resolved.

Member: Commenting on ways in which top Amersham and Old Amersham could co-operate, suggested identifying common problems like parking and condition of roads. Lots of groups and societies in the area, could they form a joint committee with one member from each group if they felt the need to discuss common problems.

Bron Curley response: This has been discussed in the past but not taken any further yet.

## ADRA Planning Report 2016

As I suspect that there will be a lot of discussion on a certain project, I will efficiently run through all the projects, which ADRA has commented on, this past year identifying the outcomes so that we can get to the comment ASAP.

The proposal for the development of an all weather pitch and flood lighting at the Amersham and Wycombe College for the Hockey Club was refused permission and went to appeal. The Appeal was upheld as the development was deemed to fit, amongst other things, in the framework of having open-air sports facilities in the green belt and that it was on ground that was already approved for sporting activity. It was advised that the sports facility would be seen as part of the education facility and hence will not look out of place.

The proposal for further development of a residence in 11 St Leonards Road from one to two dwellings was rejected and the subsequent appeal was dismissed. The design was resubmitted and the developer modified the design to accommodate the inspector's comments with regards to the buildings. As the inspector had concluded that the development in their opinion was not detrimental to the overall character of the street the number and architecture of the buildings was not altered. The development was approved subject to conformation of legal terms.

The 5 dwelling development on 54 Clifton Road, Chesham Bois is still registered but to date there is no decision.

The rear extension to 10 Bois Lane has been granted permission. This was a situation where one side of Semi-Detached residence is building a single storey extension past the rear line of the neighbour. The argument that the extension will compromise the access to light was dismissed, as it was a civil matter and not a planning issue. I am baffled to see that the



approving of a design that could lead to civil action between neighbours is not a planning issue.

A development on 16 Piggotts Orchard, which is the addition of a further dwelling on a subdivided plot, has been refused planning permission. The appeal has been upheld as the inspector determined that the design was modified enough to mitigate any issues that the neighbours have.

The proposed support living development at the North end of the High Street in Old Amersham has had its planning application refused. There has been no further movement with the development to date.

The Old Alpha garage development has been given planning permission. There has been some “movement” on site so it appears building works have begun.

The Pheasant Pub site has had a new upgraded scheme and this has been submitted. The scheme is as per their public consultation presentation and we do not see any issues with what has been proposed. The development has been approved subject to conditions.

The Waste Transfer site looks like it will go ahead. See AGM Minutes for update.

There is a development application currently submitted for 67 – 75 Sycamore Street. The proposal proposes the reconfiguring of ground floor retail with residential above. There is an anomaly with the application as there is no change of use nominated for the ground floor space although change of use is applied for. The Architecture for the development needs to be further addressed, as we do not believe it is in keeping with the rest of the street. We have opposed the development based on the anomaly of what the proposed ground floor class is and that the Architecture of the building is not in keeping with the rest of the street. The project is going to committee on 28<sup>th</sup> April 2016.



The Latest Draft Development Plan was released for public consultation in January 2016 and the 8-week period finished at the end of February 2016. This revised version is the result of the consultation process of early 2015 and is incorporating the comments, ideas and sites put forward at that time. It must be noted that it is now a joint Plan and that a lot more sites for development are being proposed.

The proposed option areas, which is probably most important to you, identified in the plan will be tested for development and the January consultation forms part of that process. Some of these areas would have been put forward by the owners or interested parties in the last consultation. The area of the sites proposed is in excess of what is required and this will be reduced after the testing process to the target number for a preferred options consultation in October November 2016.

There is no firm commitment that any area identified in this draft will be allocated for development.

ADRA did not make any contribution to the current public consultation, as we had already contributed as an organization to this plan through our input into the previous consultation. We had found no glaring issues with the document.

The very sunken drain cover on the Chesham bypass - a real car suspension breaker - has now been rectified.

Mains water leaks should be reported to Affinity Water on 0345 357 2404 or 0800 376 5325. Affinity Water then contacts the Local Authority to schedule repair work.

## Amersham Playgoers Theatre Group

The group was formed in 1946 as an offshoot of the Playhouse Theatre Club. In its heyday the Playhouse Repertory Theatre was the starting point for many aspiring actors, including the young Dirk Bogarde. Their first full-length production was 'Quiet Wedding', which they performed in November at St Leonard's Hall in Chesham Bois.

Another presentation of four one-act plays followed in March 1947. The first of these, 'Ag and Bert', featured George Marks and his wife Vera. George was one of the founder members of our group and was President until his death in May 2006. For many years George was the owner of the Pram and Toy Bar in Amersham, which was purchased by Gary Grant and became the first of his chain of Entertainer toy shops. The Marks family link continues today with George's granddaughter Louise, who is regularly seen on stage.

In Feb 1948, the group took to the stage of the Playhouse Theatre with 'Lucky Dip', although they returned to St Leonard's Hall later in the year.

In 1950 the group moved to St Michael's Hall in Amersham, where they stayed until 1956.

Between 1949 and 1951 Playgoers entered a number of drama Festivals with mixed success, but culminating in being awarded a Certificate of Merit for their production of 'A Provincial Lady'. In the early 1950s the group were usually known as PADS.

1952 appears to be the last time that the Playhouse Theatre was used and any reference to ties with the theatre disappeared, although it had gone by 1956.

Two well known names appeared in the 1955 production of 'Thunder Rock'; David Tench who later became popular for his involvement



with The Consumers Association, and Dorian Williams who became television's voice of show jumping and who spent some time as the group's President until 1960. Dame Wendy Hiller was Vice-president in the 1950s.

There was a brief return to St Michael's Hall in the early 70's, until in February 1973 Playgoers took up residence in their current home, the Drake Hall at Amersham Community Centre.

In 1982 Derek Jacobi became President of the society, a position he held for a number of years.

In recent years they have also received acknowledgements from NODA (The National Operatic and Dramatic Association). The first was in 2001; 'Swansong' written by Playgoer Doug Elkins, which received a nomination for best set in the London Region.

Since then many more plays have received nominations and in 2009 'Dangerous Obsession' claimed the Flame award for the best overall production in the area followed in 2011 by the Pat Redhead Drama award for the best drama in the entire London region for their production of 'One Flew over the Cuckoo's Nest'. The November 2011 production of 'Happy Families', again won the area Flame Award followed by a Highly Commended Scenic Award and Runner-Up in the Drama Award for The Flint St. Nativity in 2013.

In December 2004 the society name was changed from the long standing Amersham Playgoers Dramatic Society to Amersham Playgoers Theatre Group, which was considered to be more suited to the modern generation.

Playgoers are delighted to be presenting Alan Bennett's 'The Lady in the Van' for their May 2017 production. Directed by Janice Gray, this play is a bitter-sweet comedy which tells the true story of Mary Shepherd, an

elderly woman who lived in a dilapidated van on Bennett's driveway in North London for 15 years.

## Amersham Band – a long history and ambitious plans for the future

Many of you will be familiar with the sound of Amersham Band playing in the Memorial Gardens during the summer, or perhaps at Christmas, adding to the festive spirit with traditional brass band carols. In fact, the band has a very long history of serving the local community and is part of our heritage stretching back over 170 years.

Over the last few years the band has expanded its programme of performances and in 2016 played at over 30 different local events. These include formal concerts at the Wycombe Swan, Elgiva Theatre and Kings Church, together with local fetes and private events. The band also supports a wide range of civic events including the Carnival, Remembrance Sunday, and Community Christmas events.

The band has been growing strongly and there are now 3 bands; the main Amersham Band caters for experienced players, Amersham Community Brass is an intermediate band for developing players and a new Brass Roots initiative provides group teaching for beginners. In total there are now nearly 100 members of all ages and abilities. Based on recent success in attracting more people, the band is aiming to start a youth band and to launch a Brass Academy offering group and individual tuition.

An important part of the band's purpose is in delivering music education. In 2016, the band launched a pilot teaching scheme together with Woodside School which enabled 20 children the chance to have group lessons. This together with the regular Brass Roots sessions is enabling more people to experience the fun of learning music in a group. For children, music can contribute to the development of self-identity and is seen as a source of support when young people are feeling troubled or lonely. For older people, playing in a group can reduce social isolation.





The band is in need a new home in Amersham. Currently the rehearsals take place in a church hall in Winchmore Hill. This venue is now under threat of closure and is too small and difficult to access by public transport. In 2015 the band set out on a project to find a new rehearsal premises with the aim of returning to the town and securing a long term sustainable base.

After much searching, the band has decided to make a planning application for new building at the bottom of Rectory Hill, adjacent to the Doctors Surgery. An appeal fund has been started and an architect has been retained to design a purpose built premises. Care is being taken to minimise the visual impact and a traditional single storey barn-style building is being proposed to fit in with the surroundings.

When not in use by the band, it is hoped to be able to offer limited use of the building to other selected community groups, particularly music groups which could benefit from the facilities included within the building. This will be a useful additional provision as there is a recognised shortfall of indoor community space in Amersham.

Amersham Band is a fantastic community asset with a long heritage; it is hoped that the new bandroom will enable the band to continue to thrive for the foreseeable future.
