

Minutes

Minutes of the Annual General Meeting held on 13th April 2010 at Amersham Free Church Hall

1 - Chairman's Welcome The Chairman welcomed approximately seventy members to the 49th Annual General Meeting of ADRA along with guests Mayor Martin Phillips, Cllr Martin King and Mr Nigel Shepherd who will be standing at the CDC by-election on 6th May.

2 - Apologies for Absence

Ian Donnelly, Victor Faulkner, Mary McKay, Ros Makin, Ernest Newhouse, David & Janice Kerscheimer.

3 - Minutes of AGM held on 28th April 2009 Adoption of the Minutes was proposed by Geoff Sherlock and seconded by Brian Woods.

4 - Treasurer's Report (Geoff Platts)

Cllr Martin King then highlighted Amersham Town Council's forthcoming events for the remainder of 2010.

It was also stated that Town Council's offices are being temporarily housed in St Mary's Court adjacent to the community centre car park for the next six months while renovations are being undertaken.

8 - Re-election of Committee members
There were no Committee members up for re-election.

9 - Re-election of Auditor
Ernest Newhouse has agreed to continue as Auditor. His re-election was proposed by Carolyn Spencer and seconded by Brian Woods.

10 - The Chairman introduced Mr Julian Hunt who addressed the meeting on John Kennard, and the development of Amersham on the Hill.

11 - Open Forum
The formal business of the meeting having been concluded, the proceedings continued in the manner of an Open Forum.

1. Mrs Julia Holroyd raised the HS2 issue saying there had been no mention of the actual space the building of the railway would take up when including access points, emergency areas, workers' encampment etc. The Chairman responded that proposals are still in the relatively early stages and access through tunnels would be every 200m or so. Cheryl Gillan has raised questions in parliament regarding works arrangement which have been stonewalled. The report on the potential impact on the environment has not yet been released. The width of the track is to be about 70-100m. Emergency access point by Jaguar Garage in Old Amersham is marked on the plan.

2. Jim Rodda pointed out that enquiries on the construction of HS1 in Kent indicated brutal handling during preparation and construction.



3. The Chairman said it was not surprising that the first proposal did not include appendices which should be raised during consultation. Also, local groups must keep on top of the situation.
4. Geoff Sherlock enquired of the progress re proposed Sainsbury project: The Chairman had spoken with GKA Associates (Sainsbury's representatives) that morning and they were still keen to proceed, although there were still some obstacles in the way eg. not all properties acquired necessary to proceed. However, CDC views plan positively.
5. Cllr Martin King informed the meeting that Paradigm Housing are leaving Amersham Old Town and moving to Wooburn Green.
6. A member queried the proposed parking arrangements in Amersham-on-the-Hill. The Chairman felt that the installation of parking meters would not now take place due in no small part to the massive objection of residents which took BCC by surprise. Brian Woods (for Amersham Action Group) concurred with the Chairman and added that there was a fairly positive intention to include approximately three disabled parking slots close to the Post Office area.
7. A member mentioned they had previously been informed of the AGM date by post or hand delivery. The Chairman explained that the Bucks Examiner notice was booked as the Newsletter did not include this information for which he apologised. The Chairman then went on to say it had been commented that the contents of the Autumn Newsletter are somewhat out-of-date, so this year it was proposed to issue another edition to arrive in the post by the end of June to include next AGM/ January Social dates.
8. Carolyn Spencer queried whether using delivery volunteers had been abandoned. The Chairman said not completely but delivery of News-



letters and collection of subscriptions were two different chores. Subscription collections were now impossible but we can still handle some distribution using volunteers where possible and posting the remainder. ADRA still have road stewards who are happy to continue and might be happy to cover bigger areas but there are still large parts of the town where we have no support. The Chairman said the ADRA membership form is on the website if anyone would like to pass some on.

9. Bridget Woods queried how many responded to the placement of the Amersham Local advert for ADRA. The Chairman said this was an experiment and thought to be a good alternative to using the Boy Scouts who could not handle such a large delivery.

10. Nigel Shepherd queried how many members were aware of the need to reinforce the embankment along the underground line between Amersham and Little Chalfont, necessitating clearing of all vegetation along the line when London Underground's policy does not include replacement of trees which he felt was worth encouraging. A Public Meeting was held in the District Council's offices last week but nothing was agreed and more plans will be submitted probably in June with details in the press. Geoff Sherlock pointed out that there was no vegetation shown in 1960's photographs as the ashes were thrown overboard.

11. A member queried if Amersham Station's ticket office was going to be closed. The Chairman felt this would not go ahead.

12. Jim Rodda mentioned Amersham in Transition is concerned about reducing our carbon footprints. He highlighted Totnes who are carrying out a street-by-street initiative talking to neighbours. The Chairman responded by stating this would be a change in direction for ADRA but the group may possibly get involved in the future.



13. A query was raised as to whether ADRA had any information regarding when Amersham railway line was closed during weekends. The Chairman had no information but Jim Rodda pointed out that Chiltern Railway Network highlight areas with a red triangle several months ahead.

14. Joan Shepherd asked whether the bridge at Amersham station had gone for good. There was also a query as to whether anyone had queried unlocking the gate which would negate the use of the bridge. The Chairman said he would investigate.

Meeting closed at 9.45pm.



Treasurer's Report



The top left hand side of the Annual Accounts (on the reverse of tonight's agenda) records the income during 2009, together with comparable figures from 2008. The increase in subscriptions in 2009 relative to those in 2008 reflect the new subscription rate of £5.00 per year per household (ideally) collected by standing order; hence the effect of advance subscriptions will also feature in the Annual Accounts for 2011.


The subscription amount and method of collecting it have been changed; the former because yearly expenditure was tending to exceed income, and lack of Association Volunteers to collect subscriptions and distribute the Newsletter was increasing postage and stationery costs. Some thirty members have resigned from the Association rather than accept the revised subscription rates. As a consequence of the general world financial situation, income from Bank Interest is significantly down. There was no advertising income from the 2009 Newsletter. Additionally whilst a member of the Association has since 2004 donated the printing costs of the Annual Newsletter (worth about £1000); – it would not be prudent to assume this will continue indefinitely, which is another reason to attempt to increase income by increasing annual subscriptions to still relatively modest sum of £5 per year per household.

Moving onto expenditure on the top right hand side of the Accounts. As already mentioned stationery and postage costs have risen, and we made small presentations to Bridget Woods and Rosemary Dean, who resigned as Planning and Membership Officers after many years of dedicated service to the Association. We did not need to make a contribution to Christmas lights



this year – had we done so our surplus over the year, £629, would have been reduced considerably or even become a deficit.

Moving now to the lower half of the Accounts Report, we see that even with the increase in annual subscriptions our surplus at the end of 2009 was about £300 less than in 2008, however the full effect of increasing the annual subscription and method of collection has yet to materialise, and our assets appear to be adequate for the future of the Association, though our past activity will be reviewed and compared with any future proposed activity.

Highways Report

If 2008 could fairly be describe as the year of the potholes, even more so could 2009. In the latter part of the year and into 2010 I have been making several calls a week to Buckinghamshire County Council 'Highways on Call', telephone number 0845 2302882, to report potholes and made the observation that potholes once filled in often rapidly deteriorate, and noted that where the edges of repairs are sealed with liquid tar subsequent deterioration is considerably retarded. However I have been advised that sealing the edges of repairs is a danger to motor cyclists and no longer practiced. I have also questioned the necessity of having someone to mark which potholes are to be filled and which are considered not bad enough to require action – surely the man with the load of asphalt could be trained to make this decision himself!



I also make a point of reporting any failed/damaged lighting of Zebra Crossing/Traffic Bollards.

As regards parking in Amersham, acting on behalf of your committee, I have again written to Buckinghamshire County Council urging that King George V Road be retained as a timed parking road, rather than effectively become a part of the multi-storey car park with all day parking permits. We believe short term parking in this road is most desirable due to its proximity to the Library, Childrens' Playground, CDC offices and the Health Centre.

As regards the proposal to raise the 30mph speed limit in the Chesham Road, we have written to strongly express our view that this should be retained for the safety of pupils at the two schools in the road. It was reported in the local press that there was a proposal to close the public toilets in Woodside Close, near to Boots the Chemist. We wrote opposing this proposal and understand it has now been withdrawn.



Membership Report

After many years of unstinting service, Rosemary Dean decided last year to step down as the Membership Registrar for ADRA and I was co-opted to take over that role. Following the AGM, I was asked to collect the subscriptions using Standing Order instructions, as a result of which last year 176 members paid by Standing Order while another 30 paid by cash or cheque. The financial impact has been that subscription income rose from £1,461 in 2008 to £2,078 in 2009.


So far in 2010 we have received a further 141 Standing Orders from members and are waiting for 175 more to do so. The conversion exercise will be completed next year with the remaining 292 members whose membership falls due in 2011.

Sadly we have cessations of membership: some 31 households in 2009 and 17 so far in 2010.

But we want to expand our membership and so we participate in the “New Neighbours” welcome service. We have a website presence on amersham.org.uk, kindly run by Matthew Jones, where we have all of our Newsletters as well as new membership forms and we have tried to reach every household in Amersham through the March edition of “Amersham local”.

Thank you for your help and support last year. We will need each other even more in the coming months in our efforts to widen our representation.




Chairman's Report

Good evening and welcome to the 49th AGM of the Amersham and District Residents Association. We've lots to talk about this evening and it's important that we have your input on a number of topics, so I want to make sure the open forum at the end of the meeting provides ample opportunity for your questions and input.

As you all know ADRA is a voluntary organisation whose purpose is to work on behalf of its members to encourage action which will improve the quality of life in our communities. This is usually facilitated by establishing and developing effective communication on behalf of our residents with Town, District and County Councils and sometimes other agencies and groups. As a voluntary organisation we are completely reliant on the efforts of our members who come forward. But we all have lives and families and for some of us jobs do dictate what we can actually do and how much time and energy we can devote. Also, these circumstances change, so people do need to reprioritise occasionally and for us that means committee members sometimes leave. Last year Bridget Woods and Rosemary Dean retired from active service and Michael Teychenne joined to look after membership. This year I am sorry to announce that Pauline West, after 12 years has decided to leave and Alan Smith, our Vice Chairman, also resigned. On a much brighter note Mr B A Guruswamy, who we know as Guru, has agreed to join the committee and will look after the planning portfolio which Bridget vacated last year. So we say thank you and farewell to Pauline and Alan and welcome to Guru, who lives on Chiltern Road and has been "a local" for 25 years.

We still need new members; Geoff Platts, our Treasurer, is acting as Highways Officer but this really isn't quite fair. We need some new volunteers. Please consider it. Meetings the third Wednesday of every month for one and a half to two hours.




Let me give you a summary of the Planning activity for the year. Fortunately, with the state of the economy, it has been a very slow year for planning in Chiltern District, but a few significant events are worth mentioning.

The Raans Road site, where the second application for 83 homes and a church looks to be almost at approval stage, pending only final negotiation of ownership of the Church land if building isn't completed in five years (it would revert to the Council) and details around affordable housing and open spaces, which will be 2843 square metres (28,430 square feet). (One acre is 43,560 square feet, so its two thirds of an acre).

The Amersham and Wycombe College Stanley Hill Campus redevelopment plans were approved. Here also it was referred to the Secretary of State whose office had no objection despite it being Green Belt land. However, funding has been withdrawn so no work is being done at present..

Work has begun at the 130 Woodside Road site where permission was granted for 2 detached houses, 2 pairs of semis and 4 flats.

Appeal was dismissed for a block of seven flats at Clifton Road/Amersham Road. Permission to change use of the former Woolworths site from Retail to Financial Services was refused in January of this year. And finally, of greater concern to many members due to traffic considerations among others, the application for permission to convert the house beside the Beacon School was withdrawn at the end of January.





Some or all of you may have received this brochure in the last month or so. It refers to CDC's draft core strategy. The government has targeted CDC to fund and identify land for 2900 homes for the period 2006-2026. This process is part of the core strategy which will become a key document in the new Local Development Framework which will replace the Chiltern Local plan.



It is asking for input during the consultation period on the draft strategy. Sites identified include the area between Lincoln Park and Amersham and Wycombe College and the site on Bell Lane. These would hold approximately 350, and all the sites identified will accommodate 675 dwellings. 1167 have been built or are approved which leaves 1000 to be provided by 2026. Annually Chiltern District builds around 150 homes, so there's no apparent problem with

houses, but if you'd like to comment on the draft, now's your opportunity. Infrastructure continues to be a major issue.

On the subject of potholes I have recently had an update from Chris Schweer, CDC. Prioritisation for road repairs is done after inspection and assessment of severity – depth rather than surface area being the key determinant. Claims by motorists are paid out of the same funds as repairs, so each claim settled reduces the availability of road repair funds. The problem is simply funding. There isn't enough in the budget to maintain roads. You and I can continue to make noise and write letters, but until there's more money available it won't get sorted.

On a more optimistic note, Station Road is being re-surfaced w/c 19 April and the roundabouts in Amersham on the Hill the weekend after. And that transports us to another topic which some of you may be aware of. Last month the government announced through High Speed Two Limited its



intention to develop a new high speed rail network in the UK, the first link of which will run from London to Birmingham. Further work will be undertaken by HS2, at Lord Adonis's request to develop detailed proposals for lines to Manchester and Leeds from West Midlands with links from these two cities to the West Coast and East Coast main lines respectively. Proposals are due Summer 2011.

The rationale for the first link is given as speeding up journeys to Birmingham, reducing road traffic and flight traffic, providing significant economic benefits to the UK as it enables further development.



Network Rail adds it will free up existing lines to carry more freight and passengers in future. However, we mustn't overlook reality:

- *It won't address crumbling roads and the "classic" rail infrastructure currently gets £5bn subsidy annually.*
- *It is at best carbon neutral.*
- *According to the RAC Foundation research and the Eddington Review of 2006, which addressed transport broadly, only 7% of car journeys exceed 25 miles. Only 8% can be transferred to HS Rail (estimate). HSR will not alleviate road congestion.*
- *It will also do irredeemable damage to an Area of Outstanding Natural Beauty.*
- *There is no benefit for the communities most affected, only years of turmoil. Damage to our already crumbling roads will be enormous.*
- *The £17bn cost will escalate, as always is the case. It's not affordable.*



When polled by the RAC Foundation 58% of households want roads improved, 46% want car costs lowered. Only 3% want High Speed Rail. This proposal, not necessarily this route, has tri-party support in principle, if affordable, but Crossrail will not be completed until 2017. It is committed, but not fully funded. This may explain the first bill to Parliament covering London to Birmingham only, not the total HSR project as envisaged.

I think it unlikely in the current climate that this project will go ahead. There is no money, and won't be for the foreseeable future.

Our MP, Cheryl Gillan, is against it and will if necessary defy the Whip on this issue.

The route chosen is not the one Network Rail wanted which was via Milton Keynes – only 10 minutes longer journey time.

However, this is not a time to be complacent. The uproar will subside and opposition will gel into cohesive groups covering the entire route. We have of course, written to Cheryl Gillan and signed petitions to No. 10, but its early days. The consultancy period doesn't start until Autumn. At present, four groups seem to be emerging:

- *HS2action.co.uk (Quainton)*
- *Savethechilterns.org (Birkhamstead)*
- *HS2action.alliance.org, Sarah Jane Axelby leads this group from Amersham Old Town*
- *South/North Hants Group*

Also according to the Sunday Times, Lord Rothschild has committed himself to preventing this new line from going through Waddesdon.

I suggest that you write Cheryl Gillan and Lord Adonis if you haven't already. I will engage with these groups as they develop. I understand that there will be a Town Meeting organised by Amersham Town Council to engage as they develop their position later in the summer.

I believe this proposal can be stopped if the movement against it is organised and comprehensive. There are so many reasons why it's not a good idea but it will be a major struggle. We'll engage where we feel we can contribute most and as I mentioned, I suggest that as individuals we all make our feelings known.

At present there is a consultation open until 20 May on a proposal for an Exceptional Hardship Scheme. You have a notice on your chair. Please have a look at this and respond if you're so inclined.

In closing, my thanks and I'm sure yours, to our committee and my thanks to you, our supporters. And also to Alan Smith and Pauline West for their service to ADRA.

And now it's my great pleasure to welcome Mr Julian Hunt who is going to speak to us about John Kennard and the development of Amersham on the Hill.

After Julian's talk we have open forum.

Let's welcome Julian.

Groups unite against rail route

More than 30 groups against a proposed high-speed rail link have joined forces to fight the plan.

A route between London and Birmingham with a future extension to northern England and Scotland was announced by the former Labour government in March. The new Tory-Liberal Democrat coalition government has committed to the scheme but not said what the route should be. But groups in Northamptonshire, Warwickshire, Staffordshire and Buckinghamshire have vowed to fight it. They have united under the name HS2 Action Alliance which is “working for fair and just compensation”.

Announcing the plans earlier this year, former Transport Secretary Lord Adonis said subject to public consultation, trains would run from Euston to Birmingham with interchange stations west of Paddington and near Birmingham airport. The preferred route would pass through north-west London, the south-west of Aylesbury, then to the west of Buckingham and the east of Brackley and Banbury, before passing between Leamington Spa and Coventry and heading into the eastern side of Birmingham. The proposal also includes a connection with the existing rail network near Lichfield, Staffordshire.

Work is unlikely to start until 2017 at the earliest. But residents have said they are upset at the effect the route will have on their homes and livelihoods. Separate protest groups have been formed since the plans were



announced but now, they have decided to merge. Graham Long, from HS2 Action Alliance told BBC News that working together was the best way to act... "It's vital," he said. "We need to speak with one voice. We also need to raise the funds to be able to employ the sort professional help that we will have to deploy against government."
